

Charity Registration:

To register for the Sunfeast World 10K Bangalore 2010 charities are requested to do the following:

- Complete the Charity Registration Form. Submit the form along with supporting documents and your registration fee of Rs 2,000/- in favour of 'Bangalore Cares Trust'.
 - If you have already submitted the information requested in the table "Organisation Details" **you need not fill it again if there are no changes.**
 - However, you still need to provide Payment Details and complete the rest of the form
- Once your registration is processed you will receive copies of the Corporate Cares, Care Champions and iCare kits, to help you recruit supporters and promote the event
- Attend information / training sessions conducted Bangalore Cares (at a small charge to cover expenses).

What's in it for your Organisation:

- Register with Bangalore Cares to become a "Participating Charity" and become eligible for fundraising at the event.
- Recruit all your supporters to sign up as iCare Runners to collect funds for your organisation.
- Recruit your high level contacts to become Care Champions who commit to raising at least Rs. 1 lakh for your organisation.
- Invite your corporate contacts to participate in Corporate Cares guaranteeing at least Rs. 1.3 lakh for your organisation.
- Raise funds online through your appeal pages on the Bangalore Cares website.

- Get your team together, wear branded T-shirts or other crazy gear and carry banners to raise the profile of your organisation on race day.
- You may encourage your team as well as any Corporate Cares team supporting you, to wear costumes that reflect the cause of your charity in an innovative way on race day!
- You send 'Thank you' letters and feedback mails for ALL donations received in your name by Bangalore Cares. This will strengthen your relationship with your supporters.
